## Explanation of Responses:

- (1) On October 23, 2018, First Financial Bankshares, Inc. granted the reporting person restricted stock totaling 2,711 shares. The restricted stock vests 33 1/3% at the end of one year, 66 2/3% at the end of two years, and 100% at the end of three years.
- (2) The total shares represented are held in various trusts of which Mr. Dueser is the trustee, settlor and beneficiary.
- (3) The reporting person elected, in accordance with the Registrant's 2015 Restricted Stock Plan, to exercise his right to have the Registrant withhold 971 shares of the Registrant's common stock to pay income taxes related to vesting of previously granted restricted stock.
- (4) Represents shares owned by a partnership of which Mr. Dueser is the manager. Mr. Dueser disclaims beneficial ownership with respect to 208,502 shares because he does not have a pecuniary interest in such shares. This report should not be deemed an admission that Mr. Dueser is the beneficial ownership of these shares for purposes of Section 16 or any other purpose.
- (5) Represents shares owned by a limited liability company ("LLC") of which Mr. Dueser is the manager and sole member.
