- (1) The aggregate ownership of Ms. Chaya is being revised from the last Form 4 filing to correct an inadvertent miscalculation. The ownership of Ms. Chaya is being revised to include the 624 shares from the net settlement of restricted stock units previously reported on a Form 4 filed on May 16, 2017 but not reflected in her subsequent direct ownership amounts.
- (2) This stock option award will vest and become exercisable over seven years as follows: 10% of the options will vest on each of the first, second and third anniversaries of the grant date, 15% of the options will vest on each of the fourth and fifth anniversaries of the grant date, and 20% of the options will vest on each of the sixth and seventh anniversaries of the grant date, subject to continuous service.
