**Item 1. Changes in Control of Registrant**

On April 30, 2004, Mr. John Fitzpatrick, the Company's sole officer and a member of the Board of Directors since its inception, tendered his resignation as the sole member of the Board of Directors and as the sole officer of the Company. Mr. Fitzpatrick resigned his positions with the Company due to his inability to continue to dedicate sufficient time to the Company's due to personal and other professional commitments. Concurrent with his resignation as an officer and director of the Company, Mr. Fitzpatrick transferred all 100,000 shares in the Company to Mr. Chris Penner for monetary consideration and in consideration for Mr. Penner accepting appointment to the positions of President, Chief Executive Officer, Chief Financial Officer and as a member of the Board of Directors of the Company. These shares represent one hundred (100%) of the issued and outstanding stock of the Company.

Christopher Penner is currently self employed as an auto broker in Burnaby, BC Canada. Prior to being self-employed Mr. Penner worked at University Toyota for approximately 10 years. Mr. Penner will assist the Company in its attempt to locate and negotiate with a business entity for the combination of that target company.
