to provisions for death, disability, retirement, and change of control. RSUs include the right to have shares withheld to satisfy tax withholding obligations upon vesting.

- (6) The RSUs vest in 25% increments on each of the first four anniversaries of the grant date.
- (7) 2,350 RSUs granted on February 4, 2015 vest in 25% increments on each of the first four anniversaries of the grant date.
