Vesting calls for 25% per year on February 1, 2008, 2009, 2010 and 2011. Ownership of the common stock is retained directly by Tracinda Corporation and indirectly by Kirk Kerkorian who owns all of the outstanding shares of common stock of Tracinda Corporation.
