- (1) Includes 1,648 restricted stock units (RSUs) mandatorily deferred by CNS from the reporting person's annual incentive performance bonus, plus 412 RSUs granted to the reporting person as a company match on such deferral. Dividends paid on CNS common stock are reflected in additional RSUs on such deferred and matching RSUs. The deferred and matching RSUs vest ratably over four years, and the dividend RSUs vest on the fourth anniversary of the grant.
