(1) The Reporting Person was granted 31,018 shares of Restricted Common Stock under the 2006 Stock-Based Compensation Plan. 11,484 shares vest over a three-year period as follows: 3,828 shares on January 4, 2013, January 4, 2014 and January 4, 2015, respectively. The final 19,534 shares vest on January 4, 2015 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance based vested shares varying from 0 to 200% of 19,534.
