“América Móvil terminates agreement to acquire Digicel’s operations in El Salvador”

Mexico City, Mexico, October 11, 2012 -- América Móvil, S.A.B. de C.V. (“**AMX**”) (BMV: **AMX**; NYSE: **AMX**; NASDAQ: **AMOV**; LATIBEX: **XAMXL**), announced today, that in conjunction with Digicel Group Limited and its affiliates (“**Digicel**”), has terminated the agreement to acquire 100% of Digicel's operations in El Salvador.
