- (1) Includes 3.144 shares acquired through the reinvestment of dividends on March 31, 2005, at a price of \$55.9791 per share.
The number of underlying securities is based on the stock fund balance on April 5, 2005. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a April 5, 2005 stock fund price of \$55.82 per share.

- (3) The phantom stock units were accrued under the Johnson Controls Equalization 401(k) Benefit Plan and are to be settled 100% in cash upon the reporting person's retirement or other termination of service.

- (5) The phantom stock units were accrued under the Johnson Controls Executive Incentive Compensation Plan and are to be settled 100% in cash upon the reporting person's retirement or other termination of service.
- (6) Includes 27.976 phantom stock units acquired through reinvestment of dividends on March 31, 2005, at a price of \$55.76 per phantom share.
- (7) The restricted stock units were accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock Grant.
- (8) Includes 54.908 phantom stock units acquired through reinvestment of dividends on March 31, 2005, at a price of \$55.76 per phantom share.
