- (1) This transaction was effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person.  
Represents the weighted average sale price. The highest price at which shares were sold was \$131.9531 and the lowest price at which shares were sold was \$131.6901. The reporting person undertakes to provide, upon request by the staff of the SEC, the issuer, or a security holder of the issuer, full information regarding the number of shares transacted at each price.
