ITEM 1. SECURITY AND ISSUER

The class of securities to which this statement relates is common stock, par value \$.001 per share (the "Common Stock") of Magellan Gold Corporation, a Nevada corporation (the "Company"). The address and principal executive offices of the Company is 2010A Harbison Drive # 312, Vacaville, CA 95687.

ITEM 2. IDENTITY AND BACKGROUND

(d)-(f) The natural person referred to above is a United States Citizen. ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION

Item No. 3 is hereby amended to read as follows:

On June 16, 2015, Mr. Gibbs sold, in open market transactions, an aggregate of 122,668 shares of common stock of the Company at \$0.05 per share, and sold an additional 10,000 shares of common stock of the company at the current market price of \$0.07 per share on June 16, 2015.

ITEM 4. PURPOSE OF TRANSACTION

The securities of the Company were disposed of by Mr. Gibbs for investment. Mr. Gibbs reserves the right to acquire or dispose of additional shares of the Company's common stock, either in open market purchases or in private transactions.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER

Item No. 5 is hereby amended to read as follows:

(a) At the close of business on June 16, 2015, Mr. Gibbs would be deemed the beneficial owner, within the meaning of Rule 13d-3 under the Exchange Act, of an aggregate of 36,793,623 shares, consisting of 36,277,123 shares owned individually and 516,500 shares owned by Tri Power Resources, Inc., controlled by Mr. Gibbs. The securities represent 75.29% of the issued and outstanding shares of common stock of the Company. The foregoing is based upon 48,869,091 shares of common stock issued and outstanding as of the date of this report.

(b) Mr. Gibbs has the sole voting and dispositive power with respect to all of the shares of common stock identified in Item 5(a) above, except as noted.

(c) Mr. Gibbs has not purchased or sold any shares of common stock during the past 60 days, except as disclosed herein.
