KEEP options are granted at an initial exercise price of 60% of the purchase price of the shares (1) acquired and such price is reduced to the par value of the common stock over a 6 year vesting period. As a result of open market stock purchases made by Mr. Sheridan on April 24, 2012, he was granted KEEP options on July 31, 2013.
