- Mr. Sienko was awarded (i) 63,115 restricted stock units on July 1, 2015, (ii) 35,000 restricted stock units on June 7, 2016, and (iii) (1) 26,235 restricted stock units on June 7, 2017. The restrictions lapsed on 1/3 of those vesting units (41,450 shares). Mr. Sienko elected to have Hecla Mining Company withhold 13,161 shares to cover his tax liability.
