Shares of common stock will be issued on or about April 21, 2014 with 25% of the shares vesting on each of the date of issuance, March 20, 2015, March 20, 2016 and March 20, 2017, subject to continuous service through such dates.

The price reported is a weighted average price. The shares were sold in multiple transactions ranging from \$28.48 to \$28.97, inclusive.
