(1) The exercise and sale of these stock options was completed pursuant to the Rule 10b5-1 trading plan adopted by Jonathan H. Corr.

The price reported is a weighted average price. The shares were sold in multiple transactions ranging from \$25.14 to \$25.34, inclusive.
