- (1) restricted stock units will vest on February 23, 2015; 9,615 restricted stock units will vest on January 31, 2016; and 9,919 restricted stock units will vest on August 15, 2016; and 9,711 restricted stock units will vest on March 4, 2017.
  - (2) Each restricted stock unit represents a contingent right to receive one share of Zoetis Inc. common stock.
  - (3) Each restricted stock unit will be settled in shares of Zoetis Inc. common stock upon vesting.
