Bellerophon Therapeutics, Inc. (the “Company”) issued a press release on June 16, 2016 announcing that the first subject has been enrolled in the Phase 3 INOvation-1 clinical trial for patients with Pulmonary Arterial Hypertension. The first patient was enrolled by Jeremy Feldman, MD., Principal Investigator at Arizona Pulmonary Associates, Ltd. The Company has also enrolled the first subject in a Phase 2 trial evaluating the safety and efficacy of the INOpulse delivery system in patients with pulmonary hypertension associated with Idiopathic Pulmonary Fibrosis in collaboration with Professor W.
