## **TEVA PROVIDES UPDATE ON GENERIC ACTONEL<sup>®</sup> LITIGATION**

**Jerusalem, Israel, May 13, 2009** - Teva Pharmaceutical Industries Ltd. (Nasdaq: TEVA) announced today that the U.S. Court of Appeals for the Federal Circuit has affirmed a February 29, 2008 decision by the District Court, which had found Procter & Gamble's U.S. Patent No. 5,538,122 to be valid. As a result of today's decision, Teva expects to market its generic version of Procter & Gamble's Actonel<sup>®</sup> (Risedronate Sodium) Tablets no later than June 2014, when the patent is otherwise set to expire.
