(the "Stamford Harbor"), a Delaware limited partnership, on January 1, 2018 (the "Merger"), at which time Stamford Harbor, as the surviving entity, was renamed Point72 Asset Management, L.P. ("Point72 Asset Management"). In connection with the Merger, the investment management agreements between the Former Investment Manager and certain funds it managed were assigned pursuant to the Merger to Point72 Asset Management. As a result, Point72 Asset Management may be deemed to beneficially own the securities of the Issuer underlying such interests, as described in this Amendment.
