Systemax Inc. (the "Company") could not complete its filing on Form 10-K for the year ended December 31, 2004 (the "10-K") due to delays in the completion of its financial statements and related portions of the Form 10-K, which delays could not be eliminated by the Company without unreasonable effort and expense. The Company believes that it will be able to obtain and file such information by the 15th calendar day following the prescribed due date.

This delay has been primarily caused by the fact that the Company s independent registered public accountants have not completed their examination of the Company s restated results for the fiscal year ended December 31, 2003 and the first three quarters of fiscal 2004, which financial statements need to be restated due to certain errors in accounting for inventory at the Company s United Kingdom subsidiary as noted in the Company s Form 8-K dated February 21, 2005, and the results for the fiscal year ended December 31, 2004. Prior to filing the Form 10-K for fiscal 2004, the registrant plans to file an amended Form 10-K for fiscal 2003. The Form 10-K for fiscal 2004 will reflect the restatement of 2004 quarterly results as well as the restatement for fiscal 2003.
