 - (1) The stock option exercise and sales reported in this Form 4 were effected pursuant to the reporting person's stock trading plan (the "Trading Plan"), in accordance with Rule 10b5-1 of the Securities Exchange Act of 1934, as amended. The Trading Plan became effective on November 26, 2014 and will terminate on November 25, 2015, unless earlier terminated in accordance with the terms of the Trading Plan.
