TCA is an investment adviser in accordance with Rule 13d-1(b)(1)(ii)(E).

Item 4 Ownership:

TCA acts as an investment advisor to Tortoise Energy Capital Corporation ("TYY"), a closed-end investment company registered under the Investment Company Act of 1940. TCA, by virtue of an Investment Advisory Agreement with TYY, has all investment and voting power over securities owned of record by TYY. However, despite its delegation of investment and voting power to TCA, TYY may be deemed to be the beneficial owner under Rule 13d-3 of the Act, of the securities it owns of record because it has the right to acquire investment and voting power through termination of the Investment Advisory Agreement. Thus, TCA has reported that it shares voting power and dispositive power over the securities owned of record by TYY. TCA also acts as an investment advisor to certain managed accounts. Under contractual agreements with individual account holders, TCA, with respect to the securities held in the managed accounts, shares investment and voting power with certain account holders, and has no voting power but shares investment power with certain other account holders. TCA may be deemed the beneficial owner of the securities covered by this statement under Rule 13d-3 of the Act. None of the securities listed below are owned of record by TCA, and TCA disclaims any beneficial interest in such shares.
