Under the Prior Registration Statement, the registrant registered 1,200,000 shares of its common stock for issuance under the Plan. This Registration Statement is being filed to reflect an amendment to the Plan that increased the number of shares authorized to be issued thereunder from 1,200,000 to 2,500,000.
