The additional shares of restricted stock will vest as follows: 33 shares in even increments over 3 years beginning January 2, 2015, 14 shares in even increments over 5 years beginning October 14, 2019, 11 shares in even increments over 4 years beginning November 30, 2015, 32 shares in even increments over 4 years beginning January 2, 2016 and 74 shares in even increments over 5 years beginning January 2, 2016.
