(1) These shares are owned directly by Blum Capital Partners, L.P. ("Blum LP"). They may be deemed to be owned indirectly by RCBA Inc., as described in Note (6). RCBA Inc. disclaims beneficial ownership of these shares, except to the extent of any pecuniary interest therein.

(2) These shares are owned directly by BK Capital Partners IV, L.P.

(3) These shares are owned directly by Stinson Capital Partners, L.P.

(4) These shares were owned directly by Stinson Capital Partners C, L.P.

(5) These shares were owned directly by Stinson Capital Partners (QP), L.P.

(6) These shares may be deemed to be owned indirectly by the following parties: (i) Blum LP, the general partner of the limited partnerships described in Notes (2), (3), (4) and (5); and (ii) RCBA Inc., the general partner of Blum LP. Blum LP and RCBA Inc. disclaim beneficial ownership of these shares, except to the extent of any pecuniary interest therein.

(7) These shares are owned directly by Blum Strategic Partners III, L.P. ("Strategic III"). The shares also may be deemed to be owned indirectly by (i) Blum Strategic GP III, L.P. ("Blum GP III LP"), the general partner of Strategic III, and (ii) Blum Strategic GP III, L.L.C. ("Blum GP III"), the general partner of Blum GP III LP. Both Blum GP III LP and Blum GP III disclaim beneficial ownership of these shares, except to the extent of any pecuniary interest therein.

(8) These shares are owned directly by Blum Strategic Partners IV, L.P. ("Strategic IV"). The shares also may be deemed to be owned indirectly by (i) Blum Strategic GP IV, L.P. ("Blum GP IV LP"), the general partner of Strategic IV, and (ii) Blum Strategic GP IV, L.L.C. ("Blum GP IV"), the general partner of Blum GP IV LP. Both Blum GP IV LP and Blum GP IV disclaim beneficial ownership of these shares, except to the extent of any pecuniary interest therein.

(9) The Reporting Persons distributed, on a pro rata basis, 71,448 shares of Common Stock to several limited partners in one of the limited partnerships for which Blum LP serves as the general partner and transferred 4,552 shares of Common Stock to Blum LP in a liquidating distribution.

(10) The Reporting Persons distributed, on a pro rata basis, 446,215 shares of Common Stock to a limited partner in one of the limited partnerships for which Blum LP serves as the general partner and transferred 23,485 shares of Common Stock to Blum LP, who in turn distributed 23,328 shares to its limited partners.

(11) The Reporting Persons distributed, on a pro rata basis, 86,788 shares of Common Stock to several limited partners in one of the limited partnerships for which Blum LP serves as the general partner.

(12) The Reporting Persons distributed, on a pro rata basis, 22,789 shares of Common Stock to a limited partner in one of the limited partnerships for which Blum LP serves as the general partner.
