As of December 31, 2002, Select is the beneficial owner of 1,767,636 shares of Common Stock of Matthews International Corporation ("Common Stock"), for a total beneficial ownership of 5.65% of the outstanding shares of Common Stock. As the President and controlling shareholder of Select, Loening has the power to vote and to direct the voting of and the power to dispose and direct the disposition of the 1,767,636 shares of Common Stock owned by Select. Accordingly, Loening may be deemed to be the beneficial owner of 1,767,636 shares of Common Stock, or 5.65% of the outstanding shares of Common Stock.
