DEREGISTRATION OF SECURITIES

A Registration Statement on Form S-2 (Reg. No. 333-54476), was originally filed with the U. S. Securities and Exchange Commission (the "Commission") on January 29, 2001 by the Registrant (the "Registration Statement"), and was declared effective on February 13 2001. The offering of securities by certain selling shareholders named in the Registration Statement has been terminated.

The total number of shares of the Registrant's common stock registered under the Registration Statement was 5,483,333. The total number of shares of common stock sold pursuant to the Registration Statement was 4,873,709, with 609,624 registered shares of common stock remaining unsold at the termination of the offering.

Pursuant to the undertaking of the Registrant contained in the section in Part II of the Registration Statement entitled "Undertakings," the Registrant hereby requests that the 609,624 unsold shares be removed from registration by means of this Post-Effective Amendment No. 2.
