CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 22,201,290 shares or 5.6% of the 395,000,968 shares of Ordinary Shares, including American Depositary Receipts, believed to be outstanding.

Capital International, Inc., an investment adviser registered under Section 203 of the Investment Advisers Act of 1940 is deemed to be the beneficial owner of 21,469,640 shares or 5.4% of the 395,000,968 shares of Ordinary shares, including American Depositary Receipts, believed to be outstanding as a result of acting as investment adviser to various investment companies and institutional accounts.
