| Automatic early redemption: | If, on any potential autocall date, the closing value of the underlying is greater than or equal to the initial underlying value, the securities will be automatically redeemed on the immediately following contingent coupon payment date for an amount equal to the stated principal amount <i>plus</i> the related contingent coupon payment. |
| Potential autocall dates: | Each valuation date beginning in November 2018 and ending in May 2019 |
| Coupon barrier: | 77% of its initial underlying value |
| Final barrier value: | 77% of its initial underlying value |
| Payment at maturity (if the securities are not earlier automatically redeemed): | For each \$1,000 stated principal amount security you hold at maturity: If the final underlying value is greater than or equal to the final barrier value: \$1,000 <i>plus</i> the contingent coupon payment due at maturity If the final underlying value is less than the final barrier value: a fixed number of underlying shares of the underlying equal to the equity ratio (or, if we elect, the cash value of those shares based on the final underlying value) |

Selected Risk Considerations

- You may lose a significant portion or all of your investment.
