Preliminary Terms

Issuer: Citigroup Global Markets Holdings Inc.

Guarantee: All payments due on the securities are fully and unconditionally guaranteed by Citigroup Inc.

Underlyings: The S&P 500[®] Index, the Russell 2000[®] Index and the Dow Jones Industrial Average[™]

Stated principal amount: \$1,000 per security

Pricing date: November 14, 2018

Issue date: November 19, 2018

Valuation dates: November 14, 2019, November 16, 2020, November 15, 2021, November 14, 2022 and November 14, 2023 (the “final valuation date”)

Automatic early redemption: If, on any valuation date prior to the final valuation date, the closing value of the worst performing underlying on that valuation date is greater than or equal to its initial underlying value, the securities will be automatically redeemed on the fifth business day immediately following that valuation date for an amount in cash per security equal to \$1,000 *plus* the premium applicable to that valuation date. If the securities are automatically redeemed following any valuation date prior to the final valuation date, they will cease to be outstanding and you will not receive the premium applicable to any later valuation date.

The premium applicable to each valuation date will be determined on the pricing date and will be at least the percentage indicated below. **The premium may be significantly less than the appreciation of any underlying from the pricing date to the applicable valuation date.**

Premium:

- November 14, 2019: 9.75% of the stated principal amount
- November 16, 2020: 19.50% of the stated principal amount
- November 15, 2021: 19.25% of the stated principal amount
- November 14, 2022: 39.00% of the stated principal amount
- November 14, 2023: 18.75% of the stated principal amount

Maturity date: Unless earlier redeemed, November 17, 2023

Underlying return: For each underlying on any valuation date, (i) its closing value on that valuation date *minus* its initial underlying value *divided by* (ii) its initial underlying value

Trigger value: For each underlying, 65% of its initial underlying value

If the securities are not automatically redeemed prior to maturity, you will receive at maturity, for each security you then hold, an amount in cash equal to:

§ If the closing value of the worst performing underlying on the final valuation date is **greater than or equal to** its initial underlying value: \$1,000 + the premium applicable to the final valuation date

§ If the closing value of the worst performing underlying on the final valuation date is **less than** its initial underlying value but **greater than or equal to** its trigger value: \$1,000

Payment at Maturity:

§ If the closing value of the worst performing underlying on the final valuation date is **less than** its trigger value:
 \$1,000 + (\$1,000 × the underlying return of the worst performing underlying on the final valuation date)

If the securities are not automatically redeemed prior to maturity and the closing value of the worst performing underlying on the final valuation date is less than its trigger value, you will receive significantly less than the stated principal amount of your securities, and possibly nothing, at maturity.

Key Definitions

Initial underlying value: For each underlying, its closing value on the pricing date

Underlying return: For each underlying, (i) its final underlying value *minus* its initial underlying value, *divided by* (ii) its initial underlying value

Worst performing underlying: The underlying with the lowest underlying return

Hypothetical Payout Table

If the first valuation date on which the closing value of the worst performing underlying on that valuation date is greater than or equal to its initial underlying value is then you will receive the following payment per \$1,000 security upon automatic early redemption or at maturity, as applicable*:
November 14, 2019	$\$1,000 + \text{applicable premium} = \$1,000 + \$97.50 = \$1,097.50$
November 16, 2020	$\$1,000 + \text{applicable premium} = \$1,000 + \$195.00 = \$1,195.00$
November 15, 2021	$\$1,000 + \text{applicable premium} = \$1,000 + \$292.50 = \$1,292.50$
November 14, 2022	$\$1,000 + \text{applicable premium} = \$1,000 + \$390.00 = \$1,390.00$
November 14, 2023	$\$1,000 + \text{applicable premium} = \$1,000 + \$487.50 = \$1,487.50$

If the closing value of the worst performing underlying on the final valuation date is less than its trigger value, you will lose 1% of the stated principal amount of the securities for every 1% by which the worst performing underlying has declined from its initial underlying value. There is no minimum payment at maturity on the securities, and you may lose up to all of your investment.

Your potential return on the securities is limited. Your potential total return on the securities at maturity is limited to the applicable premium payable upon an automatic early redemption or at maturity.
