Dauch Gift Trust dated May 25, 1998, and the Richard E. Dauch Annuity Trust 2017, U/A 05-04-09, which together own a total of 7,150,467 shares as of 12/31/2009. Mr. R. E. Dauch, along with his spouse, is co-trustee and beneficiary of the Dauch Care Trust, which owns 433,700 shares as of 12/31/09. Mr. R. E. Dauch beneficially owns 19,680 shares of restricted stock which vests on January 6, 2010 and 79,617 shares of restricted stock that will vest no earlier than June 25, 2010. He holds options exercisable within 60 days of 12/31/09 to acquire 1,854,500 shares. Mr. R. E. Dauch individually owns 114,807 shares as of 12/31/09. Mr. Dauch is president of the Richard E. and Sandra J. Dauch Family Foundation, a charitable foundation under Internal Revenue Code Section 501(c)(3), which owns 111,710 shares as of 12/31/09.
