**Item 5. Other Events.**

On July 17, 2001, ISCO International, Inc. ( ISCO ) issued a press release announcing that it had filed suit against Conductus Inc. ( Conductus ) and Superconductor Technologies, Inc. ( STI ) for infringement of ISCO's recently issued U.S. Patent No. 6,263,215, entitled Cryoelectronically Cooled Receiver Front End for Mobile Radio Systems . The suit was filed in the United States District Court for the District of Delaware, and alleges that all of Conductus' and STI's current base station front-end systems containing cryogenically cooled superconducting filters infringe ISCO's patent. ISCO is seeking a permanent injunction restraining Conductus and STI from marketing, selling or manufacturing these products, as well as damages and attorneys' fees.
