Item 5. Other Events

On January 16, 2003, Banco Popular de Puerto Rico, a wholly-owned subsidiary of Popular, Inc., entered into a Deferred Prosecution Agreement with the U.S. Justice Department, the Board of Governors of the Federal Reserve System and the Financial Crimes Enforcement Network of the U.S. Department of the Treasury.
