The Merger Agreement is on file with the Securities and Exchange Commission as an exhibit to the Current Report on Form 8-K, as amended, filed by Hewlett-Packard Company on September 4, 2001, and is incorporated by reference into this filing.

EXPEDITING RETURNS

EMPLOYEE SHAREOWNERS AROUND THE WORLD CAN USE EXPEDITED METHODS TO RETURN PROXIES

With only a handful of days remaining before the March 19 special shareowner meeting regarding the proposed Compaq merger, HP employee shareowners who have not yet voted might consider using an expedited approach to return their proxy cards. One of the proxy solicitation companies engaged by HP has set up ways for employees to either fax their votes, or scan and e-mail them.

Please note that faxing or e-mailing may not be used to return proxy or voting instruction cards for shares that employees hold through a bank, broker or the HP TAXCAP plan. For such accounts, employee shareowners should follow the instructions provided by their bank or broker or HP TAXCAP trustee.

The expedited options are available for employee shareowners in countries outside the United States, as well as many shareowners in the United States.

Instructions for the expedited return methods have been included in recent proxy mailings and employees should refer to these instructions for details. If employee shareowners have any questions regarding their proxy cards, they should contact either GEORGESON SHAREHOLDER or INNISFREE M&A INCORPORATED.
