(i) On May 14, 2009, Davis, Sita & Company, P.A. resigned as our independent accountant engaged as the principal accountant to audit or financial statements.
(ii) Davis, Sita & Company, P.A. s accountant s report on the financial statements for either of the past two fiscal year did not contain an adverse opinion or a disclaimer of opinion, nor were its reports qualified or modified as to uncertainty, audit scope, or accounting principles, but with the exception that, in its reports on the Company s financial statements for the years ended December 31, 2008 and December 31, 2007, Davis, Sita & Company, P.A. reported that the Company s financial statements have been prepared assuming that the Company will continue as a going concern. As the certifying accountant s opinion pertained to the year ended December 31, 2008, the reason for this opinion was that the Company has incurred ongoing operating losses and does not currently have financing commitments in place to meet expected cash requirements through 2008. In addition, certain notes payable have come due and the note holders have demanded payment. In the opinion of Davis, Sita & Company, P.A., these conditions raise substantial doubt about the Company s ability to continue as a going concern.
