This filing relates to a planned merger (the "Merger") between Hewlett-Packard Company ("HP") and Compaq Computer Corporation ("Compaq") pursuant to the terms of an Agreement and Plan of Reorganization, dated as of September 4, 2001 (the "Merger Agreement"), by and among HP, Heloise Merger Corporation and Compaq. The Merger Agreement is on file with the Securities and Exchange Commission as an exhibit to the Current Report on Form 8-K, as amended, filed by Hewlett-Packard Company on September 4, 2001, and is incorporated by reference into this filing.

The following is a letter to HP employees from Carleton S. Fiorina, HP's Chairman of the Board and Chief Executive Officer. The letter refers to an enclosed speech delivered by Ms. Fiorina at a Goldman Sachs Technology Conference. The speech delivered by Ms. Fiorina was filed by HP with the Securities and Exchange Commission on February 7, 2002 pursuant to Rule 425 under the Securities Act of 1933 and deemed filed pursuant to Rule 14a-6 under the Securities Exchange Act of 1934.

Please take some time to read the enclosed speech I delivered February 4, 2002, to a group of institutional investors at the Goldman Sachs Technology Conference -- it explains the journey HP began two-and-a-half years ago, as well as the broad range of strategic alternatives the board and management reviewed to identify the best way to move the company forward. As an HP employee, it is important that you understand the reasons we have chosen to secure the company's future by leading -- not following.
