(SSF3) and Special Situations Fund III QP, L.P.* (SSFQP). (SSF3, SSFQP and Cayman will hereafter be referred to as, the Funds). The principal business of each Fund is to invest in equity and equity-related securities and other securities of any kind or nature.

*Pursuant to that certain Exchange Tender Offer described in the Schedule TO-I of the Special Situations Fund III, L.P. (SSF3) as filed by SSF3 with
