- (1) Represents common stock of the Issuer previously held by Rand Edgar Capital Corp ("RECC") and transferred on February 29, 2012 (the "Transaction Date"), to 0893306 B.C. Ltd., a private company wholly owned by Reporting Person's spouse. Prior to the Transaction Date, the Reporting Person's Spouse indirectly owned and controlled 50% of the issued shares in RECC, which assets included 1,329,924 common shares of the Issuer. On the Transaction Date, a divisive reorganization of RECC was completed which resulted in the disposition by Reporting Person's spouse of her interest in RECC and her acquisition of a 100% interest in one-half of RECC's share assets.
