On December 5, 2017, Natural Gas Services Group, Inc. (the "Company") issued a press release announcing its intent to construct, through its wholly owned subsidiary NGS Properties, a headquarters office building in Midland, Texas. The Company is finalizing the architectural design of the building and is currently in negotiations with a commercial construction contractor to construct the building. The building is expected to be three floors totaling approximately 45,000 square feet on just over 3.0 acres which the Company owns. Construction is expected to start as soon as the design details and construction contract are finalized.
