This prospectus supplement relates to the resale by the selling securityholders of 4 1/4% convertible subordinated notes due 2004 of Sanmina Corporation and the shares of common stock, par value of \$0.01 per share, of Sanmina Corporation issuable upon the conversion of the notes.

This prospectus supplement should be read in conjunction with the prospectus dated November 4, 1999, and the prospectus supplements dated November 15, 1999, December 2, 1999, December 16, 1999, January 14, 2000, February 5, 2000, March 1, 2000, March 17, 2000, April 21, 2000, May 12, 2000, July 18, 2000, August 17, 2000 and October 25, 2000 which are to be delivered with this prospectus supplement. All capitalized terms used but not defined in the prospectus supplement shall have the meanings given them in the prospectus.
