In addition, ACT Capital Management, LLLP currently owns \$325,000 of the 6% Senior Secured Convertible Notes and \$50,000 of the 8% Senior Secured Convertible Notes. Amir L. Ecker and Carol G. Frankenfield are the General Partners of ACT Capital Management, LLLP. Investment decisions made on behalf of ACT Capital Management, LLLP are made primarily by its General Partners.
