(1) Shares represent performance-based restricted stock that will vest in three equal annual installments beginning in 2008 if financial performance targets are achieved.

(2) The Reporting Person's direct holdings includes an aggregate of 126,030 shares acquired pursuant to the Reporting Person's (i) election to defer stock and/or compensation into the Deferred Compensation Plan, and/or (ii) reinvestment of dividends relating to the Reporting Person's account; and an aggregate of 3,916 shares acquired under PerkinElmer's Employee Stock Purchase Plan and or (ii) reinvestment of dividends relating to the Reporting Person's account.

(3) This option vests equally in thirds, over a three year period starting in 2008, and has a 7 year exercise term.
