By letter dated December 16, 2003, the Company reported that a holder of Company s Convertible Notes exercised it conversion right. Hence, the financial indebtedness of the Company shall be reduced in US\$ 360,862 and an increase of 662,132 ordinary shares face value pesos 1 (V\$N 1) each was made. The conversion was performed according to terms and conditions established in the prospectus of issuance at the conversion rate of 1.83486 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion the amount of shares of the Company goes from 219,984,309 to 220,646,441. On the other hand, the amount of registered Convertible Notes is US\$ 95,287,291.
