By letter dated May 28, 2004, the Company reported that a holder of Company s Convertible Notes exercised it conversion right. Hence, the financial indebtedness of the Company shall be reduced in US\$ 300,000 and an increase of 550,458 ordinary shares face value pesos 1 (V\$N 1) each was made. The conversion was performed according to terms and conditions established in the prospectus of issuance at the conversion rate of 1.83486 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion the amount of shares of the Company goes from 247,702,077 to 248,252,535. On the other hand, the amount of registered Convertible Notes is US\$ 87,057,920.
