The registrant was not able, without unreasonable effort, to complete the preparation of its consolidated financial statement disclosures relating to the closing of a new revolving credit facility. On March 30, 2012, registrant's wholly-owned subsidiary, Brookwood Companies Incorporated ( Brookwood ), and its subsidiaries, entered into a new revolving credit facility by and among Brookwood, its subsidiaries and Branch Banking & Trust Company. The new facility replaces Brookwood's former revolving credit facility with KeyBanc.

The registrant believes that inclusion of information about the new revolving credit facility is integral to the filing of the Form-10K.

Concurrent with the filing of this Form 12b-25, the registrant has been able to complete preparation of its financial statement disclosures relating to the new revolving credit facility and, accordingly, has filed its 2011 Form 10-K and included the completed loan agreement as an exhibit.
