(e) Compensatory Arrangements of Certain Officers.

On October 7, 2015, the Compensation Committee (the Compensation Committee ) of the Board of Directors of Puma Biotechnology, Inc. (the Company ) approved an increase in the salary of Alan H. Auerbach, the President and Chief Executive Officer of the Company, from \$630,000 to \$693,000. The increase is effective retroactively as of September 1, 2015.

In addition, on October 8, 2015, the Compensation Committee approved an increase in the salary of Charles R. Eyer, the Senior Vice President, Finance and Administration and Treasurer of the Company, from \$333,108 to \$372,600. The increase is effective retroactively as of September 1, 2015.
