- The Series A Preferred Stock and the Series C Preferred Stock were issued to Advance/Newhouse Programming Partnership ("ANPP") in connection with an overall restructuring (the "Restructuring") of Discovery Holdings Company ("DHC") pursuant to the Transaction Agreement, dated as of June 4, 2008, by and among the Issuer, DHC and ANPP and certain of their respective affiliates. Further information regarding the Restructuring can be found in the Form 13D filed by ANPP, Newhouse Broadcasting Corporation, Advance Publications, Inc., Newhouse Family Holdings, L.P. and Advance Long-Term Management Trust with the Securities and Exchange Commission on September 29, 2008 with respect to the Issuer.
- (1) 792,361 shares of Series A Preferred Stock and 792,361 shares of Series C Preferred Stock are held by JPMorgan Chase Bank, as Escrow Agent, pursuant to the Escrow Agreement, dated September 17, 2008, among the Issuer, ANPP and JPMorgan Chase Bank.
