**TD Bank Financial Group Comments On Expected Impact of  
TD Banknorth Inc.'s Fourth Quarter Earnings**

TORONTO, ON January 24, 2007 - TD Bank Financial Group announced today that it expects TD Banknorth's fourth quarter earnings to translate into first quarter net income for its U.S. Personal and Commercial Banking segment of CDN\$64 million.

TD Bank Financial Group will release its first quarter financial results and webcast its quarterly earnings conference call live on the internet on Thursday February 22, 2007. Conference call and webcast details will be announced closer to the date.
