As of the close of business on March 28, 2012: i) Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), beneficially owned 2,058,011 shares of the Issuer's Common Stock; ii) Integrated Assets II LLC, a Delaware limited liability company ("Integrated Assets II"), beneficially owned 89,975 shares of the Issuer's Common Stock; and iii) Cognizant Holdings, Ltd., an exempted limited company organized under the laws of the Cayman Islands ("Cognizant Holdings"), beneficially owned 15,342 shares of the Issuer's Common Stock, which collectively represented 5.1% of the Issuer's Common Stock outstanding.

However, as of the close of business on April 4, 2012, Integrated Core Strategies beneficially owned 1,883,011 shares of the Issuer's Common Stock and Integrated Assets II beneficially owned 155,568 shares of the Issuer's Common Stock, which collectively represented 4.8% of the Issuer's Common Stock outstanding. As of the close of business on April 4, 2012, Cognizant Holdings no longer beneficially owned any shares of the Issuer's Common Stock.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and Integrated Assets II and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II.

Israel A. Englander, a United States citizen ("Mr. Englander"), is the managing member of Millennium Management. Consequently, Mr. Englander may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II.

The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies or Integrated Assets II.

(b) Percent of Class:

As of the close of business on April 4, 2012, Millennium Management and Mr. Englander may be deemed to have beneficially owned 2,038,579 shares or 4.8% of the Issuer's Common Stock outstanding (see Item 4(a) above), which percentage was calculated based on 42,633,430 shares of Common Stock outstanding as of February 14, 2012, as per information contained in the Issuer's Form 10-K dated February 24, 2012.
