- (1) Represents vesting of the 2015 Performance Based Restricted Share Units granted on March 6, 2015 under the Issuer's 2013 Equity Incentive Plan (the "Plan"). Subject to the terms of the grant, Mr. Thomas received 65,998 common shares upon vesting. Includes 302 shares acquired under the Dividend Reinvestment and Share Purchase Plan. Further, it includes the performance share units award granted under the Issuer's 2013 Equity Incentive Plan on March 3, 2017, which 60,606 shares represents the "target" number of shares underlying the performance share units outstanding. The exact number of shares to be issued upon vesting depends upon, among other things, the Issuer's financial performance. Subject to continued service, the shares, if any, will be issued following the performance period end date of December 31, 2019.
